Special terms and conditions for category Air Conditioner

- 1. Scope of installation and Commissioning for Cassette AC
 - 1.Mounting/Fitting of indoor and outdoor units at the respective locations after cutting the false ceiling / drilling holes into the roof, if required.
 - 2.Laying of refrigerant piping and connecting with indoor and outdoor units after drilling hole/holes in the wall, if required.
 - 3. Charging Refrigerant gas in the unit.
 - 4. Suitable electric wiring between indoor unit and switch upto 3 meters length.
 - 5.Testing for satisfactory working without any abnormal noise as well as leakage test of entire system.
- 2. Following are not included in the scope of supply for Cassette AC:
 - 1. Refrigerant pipe of required length.
 - 2. Set of 4 nos. of Rods for fixing Cassette AC to the roof.
 - 3. Chiselling / Ducting / grooving for concealing the Refrigerant piping / cabling.
 - 4. Switches/ Sockets / Plug Tops / Voltage Stabilizer.
- 3. Scope of installation and Commissioning for Floor Standing Split AC
 - 1. Mounting/Fitting of indoor and outdoor units at the respective locations.

- 6.In addition to general terms and conditions of the GeM following special T&C shall be applicable:
 - 1. "Refrigerant Pipe / Refrigerant Piping", wherever is referred in this document, means, "Set of two copper pipes one for suction other for discharge with suitable insulation for carrying the Refrigerant along with suitable connecting electrical cable...

- 1.Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.
- 2.Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.
- 3.Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.
- 4.Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.
- 5.Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the year. In case of bunch bids, the primary product having highest value should meet this criterion.
- 9.Installation, Commissioning, Testing, Configuration, Training (if any which ever is applicable as per scope of supply) is to be carried out by OEM / OEM Certified resource or OEM authorised Reseller.
- 10.Scope of supply (Bid price to include all cost components) : Supply Installation Testing Commissioning of Goods and Training of operators and providing Statutory Clearances required (if any)
- 11. While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.
- 12. **Upload Manufacturer authorization:** Wherever Authorised Distributors are submitting the bid, Manufacturers Authorisation Form (MAF)/Certificate with OEM details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid.
- 13. Buyer reserves the right to postpone schedule of material supply after finalisation of order by 6 months without any additional cost implication.
- 14.Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.
- 15. Loading and Unloading at yard will be under the scope of the supplier.
- 16.OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

17.**OPTIONAL SITE VISIT:**

- 1. The Bidder is advised to visit and examine the installation site and its surroundings and obtain for itself on its own responsibility all information that may be necessary for preparing the Bid. The costs of visiting the site shall be borne by the Bidder. All expenses will be borne by the bidder only.
- 2. The Bidder representative shall be allowed entry upon consignee premises for such visits, only upon the express conditions that the Bidder will release and indemnify the Buyer and Consignee against all liabilities arising out of such visit including death or injury, loss or damage to property, and any other loss, damage, costs, and expenses incurred as a result of such visit.

- 3. The Bidder shall not be entitled to hold any claim against Buyer for noncompliance due to lack of any kind of pre-requisite information as it is the sole responsibility of the Bidder to obtain all the necessary information with regard to site, surrounding, working conditions, weather etc. on its own before submission of the bid.
- 18. Scope of supply includes Training: Number of employees to be trained 2, Place for Training Indira Gandhi Engineering College, Sagar (MP) and Duration of training 1 days.
- 19. The successful bidder has to supply all essential accessories required for the successful installation and commissioning of the goods supplied. Besides standard accessories as per normal industry practice, following accessories must be part of supply and cost should be included in bid price: Wiring (Total length for all 6 ACs = 20 meters, 3 core, 6 sq. mm, this wire should be in addition to the standard accessories), piping, tapes for covering the insulation, switches & switch boards (6 no.), MCB (6 no.), MCB Boxes (6 no.), outdoor stands (6 no.), drain pipe, outdoor unit to be installed at the outer wall of 2nd floor.
- 20.ISO 9001: The bidder must have ISO 9001 certification.
- 21.NET WORTH: Net Worth of the OEM should be positive as per the last audited financial statement.
- 22. For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:
 - a. Purchase Order copy along with Invoice(s) with self-certification by the bidder that supplies against the invoices have been executed.
 - b. Execution certificate by client with order value.
 - c. Any other document in support of order execution like Third Party Inspection release note, etc.

This Bid is also governed by the General Terms and Conditions

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
